### **ORDER:**

The Hon'ble Chief Minister of Tamil Nadu in a press meet at Nilgiris on 21.05.2022 has stated that the unorganized workers involved in the Tourism sector in the District of Nilgiris will be enumerated and provided with the benefits of welfare schemes of the Tamil Nadu Unorganised Workers Welfare Board.

In the letter second read above, the Commissioner of Labour has requested to notify the Employment of tourist guides and tourism related works as the 70<sup>th</sup> entry in the Schedule of Employment under section 29 of the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982) for providing welfare assistances to the registered unorganised workers who are employed as tourist guides and in tourism related works.

3. After careful examination, the Government have accepted the above proposal of the Commissioner of Labour. Accordingly, the appended Notification will be published in the extraordinary issue of Tamil Nadu Government Gazette. The Works Manager, Government Central Press, Chennai-600 001 is requested to send ten copies of the Gazette to the Government and ten copies to the Commissioner of Labour, Chennai-600 006, directly.
